Lessee/Kennel shall use the greyhound only in the usual ordinary, and accepted way Greyhounds are customarily used in Greyhound racing.

C. No Lessor, Lessee or Kennel shall enter or permit a Greyhound to be entered in a race if that person knows that the Greyhound was trained with live lures or animals killed for purpose of training.
